STAFF REPORT - GENERAL ITEMS

Scotts Valley Water District

Date: October 12, 2017

To: Board of Directors

- 1. According to California Department of Water Resources, water year 2017 (WY 2017) did not break records as the state's wettest year. The US Bureau of Reclamation reports that as of September 30, the last day of WY 2017, the Central Valley Project's six key reservoirs held carryover storage of 8.9 million acre feet (AF) 4 million more than a year ago and 6 million more than in 2015. As for snowpack, May 1 electronic readings showed a statewide snow water equivalent of 42.5 inches, 196 percent of the average for that date, just short of the 201 percent measured May 1, 1998. WY 2017 rainfall in Scotts Valley was 80.14 inches or 193 percent of the long-term average.
- 2. A proposal to tax California's drinking water (SB623 by Sen. Bill Monning) stalled in the Legislature. On September 1, the Assembly Appropriations Committee referred the bill to the Assembly Rules Committee as a two-year bill. This was an "all hands on deck" effort for ACWA and ACWA member agencies. SB623 is expected to continue to be top priority legislative issue for ACWA in 2018.
- 3. 2017 ACWA Region elections ballots have been counted and results are in. Region 5 (which includes Scotts Valley Water District) Board for the two-year term starting January 1, 2018, is comprised of the following individuals:
